AN ALERT TO EMPLOYEES CONTEMPLATING RETIREMENT . . . Federal employees must retire by 30 December 1963 to get the four per cent increase in annuity. On 31 December 1963 (and through 30 December 1964), the annuity increase will drop to three per cent. However, Federal employees' salary will be increased on 1 January 1964 and employees who retire on or after that date will be paid for their accumulated annual leave at the high pay rate. For this reason, it may be to the advantage of some employees to forego the one per cent difference in annuity increase and retire in 1964 rather than in 1963.

NEW DEPARTMENT OF DEFENSE POLICIES AND PROCEDURES FOR MINIMIZING ECONOMIC IMPACT ON COMMUNITIES RESULTING FROM ADJUSTMENTS IN DEFENSE PROGRAMS . . .

A new Department of Defense Directive reads in part as follows:

"Our present efforts to place career employees adversely affected by reductions or shifts in staffing, by base closures, and by other management decisions, should be expanded and given greater Department of Defensewide emphasis. Firm measures are required to promote greater stability of of employment for career employees whose positions are affected by shifting defense staffing requirements.

Specific steps, . . . , will be initiated at once with regard to: advance planning and notice to employees, payment of transportation and travel expenses for employees who must be relocated, priority referral and placement within the Department of Defense for Department of Defense employees being involuntarily separated, and retraining of employees made surplus in their present positions. Separation of employees by reduction-in-force will be used only as a last resort and after all other measures have failed.
