MINUTES

CORPUS CHRISTI BUSINESS DEVELOPMENT COMMISSION Lifestyle Task Force January 26, 1983

The first meeting of the Lifestyle Task Force was held Wednesday, January 26, 1983 at 4:00 p.m. in the Chamber of Commerce board room. Members in attendance were: Ernest Briones, Romeo C. Garcia, Rev. Elliott Grant, Jim Gunn, Rick Harrison, Judge Noah Kennedy, Dr. Vance Littleton, Dr. Jean Richardson, J. David Salinas, Larry Tucker, and Dr. Miriam Wagenschein. Absent: Carlos R. Moreno, Dr. B. Alan Sugg, Dr. Hector P. Garcia, and Robert M. Kendrick. Others present: Brodie Allen, Rudy Gonzalez, and Elaine Black.

Miriam Wagenschein opened the meeting by introducing the Business Development Commission staff and Task Force committee members. Brodie Allen was asked to give the group some background information on the Fantus Company. Dr. Wagenschein stated that overall, the study on Corpus Christi was favorable but, some issues of the report would need to be addressed.

The purpose of the Task Force is to determine if the statements in question are accurate. If not, some recommendation should be made on how it can be corrected.
