Dear Dr. Carcia:

This is to let you know that I have received a letter from Mr. Julio Calderon regarding his wish to obtain employment as a chemist in either the armed or civil service. I understand that Mr. Calderon has also contacted my colleague Congressman Solomon P. Ortiz, but that he inverted the addresses on correspondence sent to Washington.

As I had previously indicated, we have referred Mr. Calderon to Congressman J. J. Pickle of Austin. Although I appreciate Mr. Calderon's interest in keeping members of the Congressional Hispanic Caucus apprised of his situation, I want to reiterate that Congressman Pickle must be permitted to offer assistance to his own constituents. Unfortunately, I am unable to impress this upon Mr. Calderon directly, as he has not included his Austin address in his recent correspondence.

After discussions between my staff and that of Congressman Ortiz, we are agreed in sympathizing with Mr. Calderon's wishes. We both also attest to our confidence in Congressman Pickle. I am sure that he will do his best on behalf of his constituent.
