SESQUICENTENNIAL TORCHLIGHT PARADE REGULATIONS - MARCH 2, 1986

- Each entry should be in good taste and should represent the theme of the parade.
- 2. Motorized vehicles will be kept to a minimum in keeping with our theme. They should be cleared with the parade chairman unless you have already done so. Horses, wagons, ponies, donkey should be used to the extent possible. Vehicles, if used, must be docorated.
- (a). For safety: Vehicular-towed floats must have a tested fire extinguisher.
  - (b). For Safety: No flowers, candies, or anything whatsoever may be thrown from any entry.
- All entries please be in place at the assembly area no later than
  6:00pm Sunday. The parade will commence at 7pm.
- 5. The assembly area will be on the south side of Shoreline Drive, facing south, commencing at the Chamber of Commerce Building. The parade route will be moving south on the northbound lanes of Shoreline and continuing to the Coliseum parking area where recovery vehicles and horse trailers should be parked.
- 6. The parade is planned to be a slow-moving parade so that the spectators may enjoy the beauty of it. A 40 foot interval must be maintained between units in the parade.
