Dear Dr. Cardenas:

This is in reply to your request of March 2, 1977, regarding the status of the districts in Texas, Louisians and Arkaness included in the Lou compliance effort.

The answers are addressed to each one of your impulsies in the same order as your letter:

- I. The on-site reports of the fifteen districts visited, four-teen in Texas and one in Louisians, have been finished. The letters of findings have been drafted but, to date, have not been cleared by the Brooch Chiefs and the Office of the General Counsel. Since these letters have not been mailed to the districts, it would be inappropriate for us to give you the specific status of each one regarding their compliance with Title VI and the Lou Remedies. However, we can say that a substantial number of the districts reviewed are in probable noncompliance with Title VI/Lay.
- 2. No lim investigative activity, to date, has taken place for the remaining 45 Texas school districts included in the <u>Lan</u> compliance effort.
- 3. The only Lou district identified in Louisians, Jefferson Forish, was reviewed on-site, as explained above. There were no districts in Arkansas included in the Fall 1974 Lau compliance effort.
- 4. At present, six Texas Law districts have been tentatively identified for on-site reviews commencing in either April or May, 1977. These districts are:

We satisfy that the Lau review activity will be increased for FY78. In all probability the 40 Texas districts initially identified will be included in next year's enforcement activities. We will advise you upon completion of our Amusi Operating Plan.
