Dear Hector,

There are a substantial number of constituents in the 20th Senatorial District that have suffered because they are not represented in the Texas Legislature. This is especially true of our industrious, taxpaying citizens, and includes the Medical Profession.

One asset that will help me establish a direct line of communication with the Spanish-speaking constituency of our area is my ability to speak Spanish fluently.


Running for office requires a great deal of effort, time, and financial sacrifice on my part. I am willing to make the sacrifice.
