Dear Hector:

The Department of Energy moved to defederalize the guards services at Los Alamos National Laboratory. The GI Forum opposed the decision and for the last four or five months we have been trying to keep DOE from defederalizing the guards. The main reason for our position is that all of the guards are veterans and 106 of the total 146 are Chicano or Hispanic who have served for many years.

We went before the DOE appeals board and they ruled against us. It was tough to take the defeat, but we are determined to support the veterans and more specifically the Chicanos. We have, therefore, decided to go to the courts and try to stop the DOE action. Secondly, we have gone to the Congress to stop the action by way of legislation.

It's on this matter that we need your help. The Congress unanimously passed the amendment which is shown in the attached letter of Congressman Lujan. It is now up to the Senate to accept the amendment. The Senators from New Mexico (Domenici and Schmidt) are supposed to be helping us. However, unless other Senators back the amendment I doubt that we can win the vote.

Our request to you is that you contact Senators Bentsen and Tower and ask that they support the amendment to keep the federal guards rather than to contract for the security services.

The American GI Forum is the only organization that stood the test and we need to show strength in the northern part of New Mexico and let people know that if we have to go it alone that we can still win.

Dear Hector:

This is a follow up of my second letter in which we ask for your help on an amendment to the DOE appropriations which would in affect stop the defederalization of the guards services at Los Alamos National Laboratory.

As I indicated in my letter, we thought that Senator's Domenici and Schmidt would help us, but the latest development is they probably won't. Senator Schmidt has already told the press that he will probably not carry the amendment in the Senate and Domenici has said nothing. However, at the DOE appeals board I had expected Senator Domenici's representative to make a statement on our behalf. I assume they would since they had supported us before the Armed Services Congressional Committee.

It now seems the Reagan administration has put the arm on the two Senators and they will probably not do anything about the amendment. I suspect that the Republican Senators will also march if neither Schmidt or Domenici move on the matter.

That leaves some Democratic Senators who are willing to buck the administration to make an issue amendment.

Please let me know if there is anything that can be done to help.
