Dear Dr. Garcia:

I think we are about to see a breakthrough in the battle which you have waged against discrimination in the higher echelons of the postal service in Texas. Men such as Ricardo Perez of your own city and Martin Garza of San Antonio have risen rapidly and they and several others are scheduled for further advancements. Under a reorganization plan now pending, three Mexican-Americans will move up to the Dallas Regional Office.

Victory in the battle against discrimination is a group victory. It will aid Mexican-Americans as a group. It will not guarantee that a particular person will get a particular job--nor should it.

I am advised that Raime Muguerza failed to pass the supervisory examination which is one of the prerequisites of the position of Finance Examiner. Raime answered 88 questions correctly whereas he needed to answer lll correctly to pass. I think you will agree that the merit system, fairly administered, is a bulwark against discrimination. If the supervisory examination is a valid instrument, then to promote Raime would be to discriminate against those who can pass the examination.

If you do not agree with my reasoning or if you have any evidence that Raime was not fairly tested, I certainly want to hear from you.
