I am 38 years old and my wife is 26. I am presently employed as a financial analyst at the Securities and Exchange Commission in Washington, D. C., GS-11, with a gross yearly income of \$9221.00. Although my wife, Sally Ann, is now employed as part-time help at the National Association of Sheltered Workshops and Homebound Programs, Washington, D. C., she is planning to quit whenever the adoption procedure becomes effective so that she will be home to care for the child.

We have a two bedroom apartment with ample space for raising a child. We are planning to buy land soon and build a home so that we will have an even better atmosphere in which to raise a family. My wife and I are both active Christians.

Sally Ann and I both were born in Johnstown, Pennsylvania and moved to the D. C. area in March of 1961 and since such time I have been employed by the SEC.

We want so much to give a young unwanted child a home where it will be loved and will have an equal chance to make a good future for itself. We know that there are many children born each week who may never have the love and guidance which it will need in order to be a whole and sound individual and to go on helping others when the time comes for it to leave home. We will do our very best to give this child what it needs to be a mature, loving and independent adult.
