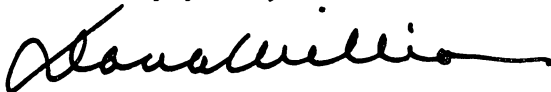
If I am to be successful here as your school leader, it is extremely important that I have the understanding and support of all of our people and especially those in positions of great leadership and influence.
