Attached is the latest copy of TRIBUNA, of which he is Editor-in-Chief, and through which he has managed to extort monies from local politicos and friends in business, and most important, through which he is able to publicize his personal ideologies and fancies in imposition upon an unsuspecting public. At the present time, I under stand that he and his family are living with a Mrs. Rosa Morfin at 3456 Massachusett in Gary, Indiana. Rumor has it that Mrs. Morfin is quite put out since he has promised and promised to contribute something for his room and board but nothing has been paid his benefactive, to date. He claims that he is waiting for his check to come in from the Ford Foundation, an organization which we now know is not sponsoring him in the least.
