Dear Dr. Garcia,

I am writing this letter to you requesting your advise on an issue that occured at the La Feria High School where my son, Edward Guy Trevino, is due to graduate from at the end of this school year.

My son's name is Edward Guy Trevino and he is 17 years of age. I am aware of my son's faults as well as his assets. I do not try to "cover-up" for my son. Yet I feel that the punishment given to him for his misbehavior is very drastic as they seek to expell him for the remainder of the year and not let him graduate.

On May 9, 1990 Edward was given a piece of paper with a friend's private phone number on it. The substitute teacher, Mr. Ybarra, saw them passing this paper and wanted to retrieve it, Edward refused to give it to Mr. Ybarra. At that point Mr. Ybarra told him to go to the Principal's office so they could have the paper physically removed from his person. Edward refused, Mr. Ybarra then took hold of his arm and Edward physically removed the teachers arm, so he could leave, Edward then went to his grandmother's house, he says to "cool-off" and then he returned to school about an hour later to apologize. He was told by Mr. Renaud to leave the school grounds.

I was called at work by Mr. Renaud. He says he was calling to inform me of the incident. Asked if I would meet with him.

I met with Mr. Renaud: on the morning of May 10th. A decision had already been made, as Mr. Renaud had already decided to expell Edward for the duration of the school year. For what reason Mr. Renaud wanted to meet with me I do not understand, I was under the impression that together, Mr. Renaud and I could come to some sort of action on Edward's behavior.
