## THE HECTOR PEREZ GARCIA PAPERS: UNTAPPED RESOURCE

## Abstract

Dr. Hector Perez Garcia, founder of the American G.I. Forum and prominent Corpus Christi physician, for a number of years has been donating his papers and other materials to the University Library Archives of Corpus Christi State University. Lack of publicity due to legal and institutional restrictions on its use has caused this rich resource to be relatively untapped by researchers. Now, more readily available to the public, these materials can offer opportunities for discovery or appraisal of the development of an important Mexican American activist movement, as well as unique insight on the history and culture of the southwestern United States and South Texas in particular.

The aim of this paper is twofold. First, the content of the Garcia Papers will be examined in light of its potential usefulness by historians and social scientists, with particular emphasis on the issues of education, gender, religion, and socioeconomics. Second, some suggestions will be offered regarding the effective utilization of the askSam data base text retrieval system on which a majority of the materials are catalogued. The author, an anthropologist, will base her comments on the year spent working toward the conservation and cataloging of these materials.
