Dear Dr. Garcia,

Oh behalf of my brother and codefendants, Oscar Mendoza, and June Bunch Mendoza, I am appealing to you for assistance with the U.S. Parole Commission and the office of the U.S Attorney General.

We have been incarcerated since September 26, 1986. We were charge and eventually convicted of conspiracy, possession, Aiding & Abetting the distribution of heroin. We all received lenthy prison sentences, out of the Western District of Texas. But we've resided in Corpus Christi, since coming our parents came to Corpus Christi, in 1939.

My father, Mr. Gregorio Mendoza, who lives at 3010 Elgin Street was recently diagnosed with cancer of the lung and bone marrow. We have served 117 months of the 120 months required before an initial parole hearing is granted, for sentences of 30 years and over. Oscar received 45 yrs, and 45 yrs Specail Parole. June received 40 yrs, and 40 yrs Specail Parole, (June's first offense) I was given 35 yrs and 35 yrs Special Parole. We are appealing to you for assistance in obtaining a "hearing on record" and rendered a presumtive parole date. As the situation stands now, we are not elgible for bedside or funeral furloughs, unless we are chained, and accompanied by two armed guards for each of us. However, if we are granted a presumtive parole date, we may become elgible for unescorted family furloughs, and perhaps become elgible for a minimum security camp or half-way house.

Your intervention on our behalf would be greatly appreciated by us all, and each member of our families.
