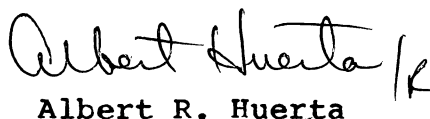
Dear Mr. Stone:

Dear Hector,

In the next several months I will be finalizing my decision on whether to seek another term in the U.S. Senate. Frankly, I am leaning in that direction, but I wanted to take this opportunity to share some personal thoughts with you and others who have been friends and supporters for a long time.

The primary consideration, as it has been throughout my career in both private enterprise and the public arena, is whether or not I have something to contribute. This is balanced against what is best for my family. As a young County Judge in South Texas and then as a Congressman, I felt that public service was the noblest calling, particularly for one of the millions of young Americans who had just fought for democracy and freedom during World War II.

By the Mid '50's, I realized that raising a family and experience in the business world were equally important. For the next 16 years, B.A. and I did exactly that. We loved every minute we spent in Houston with our children and in starting a business and watching it grow.

But by 1970, the kids were either in college or off on their own careers. The call of public service was still strong and we made the decision -- B.A. and I and many friends such as you -- to seek a seat in the U.S. Senate. Together we ran and we won. We did so again in 1976 and in 1982. Those years in the Senate have been rewarding and with the passage of time I have earned greater seniority, giving me greater opportunity to be of help to the people of Texas. Last year, with the political change in the Senate and because of the seniority I had built up, I was elected Chairman of the powerful Senate Finance Committee.

A great deal of the future economic well-being of our country rests on determinations made by this committee. America is at an economic crossroad, not only at home, but also with our trading partners abroad. I believe my background, the combination of public service and private business, has given me the experience to help mold policies which will make us competitive in the 21st Century.

This will not happen overnight, nor will it happen easily. A great deal of my time in the months ahead will be devoted to crucial matters before that committee and the Senate.

Because so much of my schedule will be concentrated in Washington, I must call upon your support once again in two crucial areas.

First, I hope you will take an opportunity to talk to your friends and associates about my record in the United States Senate. Your personal public support will mean a great deal, not only to me but also to those who value and respect your views.

Second, I hope I can call upon you once again to generously support my 1988 campaign with a contribution. Your early contribution, coupled with those of others who have supported me in the past, will be a very clear signal to any possible opponent that I have the strong backing of Texans from all walks of life.

I have been more than blessed throughout my career. B.A. and I know full well that most of those gifts have been bestowed by friends such as you. With that knowledge, I will do everything in my power to ensure that the full blessings of America will continue to flow to our children and future generations.
