Dear Dr. Garcia:

I genuinely appreciate your comment about the nomination of Judge Robert H. Bork to be an Associate Justice of the Supreme Court. In my judgment, the President's choice is a good one and I shall support the Bork nomination.

Judge Bork has a distinguished record: He has been a member of the U.S. Marine Corps Reserve, a lawyer in private practice, a professor at Yale Law School, Solicitor General of the United States, and a judge on the U.S. Circuit Court of Appeals for the District of Columbia. The Senate confirmed him unanimously for the circuit court bench on February 8, 1982. By any objective standard, he is eminently qualified for service on the Supreme Court.

Equally important, in my opinion, Judge Bork understands the role that the framers of the Constitution had in mind for the federal judiciary. Federal courts were not established to hamstring the police, free hardened criminals, usurp congressional and state powers, or act as social engineers for liberalism. Yet that is what the courts have done repeatedly over the past 25 years.

Ironically, the lack of law and order in American society today is largely the result of federal judges who sought power for themselves instead of upholding the law. By elevating Judge Bork to the Supreme Court, President Reagan has made another important step in reestablishing a law-abiding federal judiciary.

Thank you for your letter stating your support of S.J. Resolution 13, the English Language Amendment, making English the official national language. I have received a variety of letters on this topic.

Opponents of the English Language Amendment in its current form look at the vague language of the bill and point at potential threats to valued goals: bilingual education, a fair election process, fair court proceedings, minority rights, and even maintainance of national respect towards the multitude of cultural heritages in the United States.

However, those who share your convictions point to national unity and pride, which are also valued and worthwhile goals. I am aware of the problems other countries, such as Canada and Belgium, have with multiple languages. I also recognize the efforts being made to avoid similar rifts in the United States. Setting English apart as the official national language is one such effort.

Currently, S.J. Resolution 13 is pending before the Committee on the Judiciary. Recognizing that this legislation carries great impact as a Constitutional Amendment, I will be following the debate on this bill very closely in the coming months. Should this issue come to the Senate floor, I will certainly keep your views in mind.

As you know, on July 1, 1987, President Reagan nominated Robert H. Bork to replace retiring Supreme Court Justice Lewis Powell. The Judiciary Committee began hearings on the nomination September 15th. I expect the nomination to reach the Senate floor in early October.

There are very strong feelings on both sides of the issue of whether Judge Bork should be confirmed by the Senate and my decision will be a difficult one. Thank you for your recent letter and for taking the time to send me copies of the resolutions adopted by the American G.I. Forum of the U.S.

I appreciate knowing of your opposition to an amendment to the Constitution that would make English the official language of the United States. You are correct that such an amendment could have profound effects on bilingual education and ballots. As you know, S.J.Res. 13, which would propose an English language amendment, is currently pending before the Senate Committee on the Judiciary. As always, you may be confident that knowing of your opposition to this measure will be helpful to me should the full Senate consider this legislation.

I also understand your deep concern about President Reagan's nomination of Judge Bork to fill the vacancy on the U.S. Supreme Court created by the retirement of Justice Lewis Powell.

Certainly no one questions Judge Bork's academic and legal credentials, but that is not the only question. It is his philosophy that troubles many people. For example, I voted against the poll tax when I was in the U.S. House of Representatives some 35 years ago. I have long believed that it was an unfair restriction on our right to vote, one of our most precious rights. I am troubled by reports that as recently as two years ago Judge Bork disagreed publicly with a 1966 Supreme Court decision outlawing the poll tax.

I have not decided how I will vote on Judge Bork's nomination to the highest court in the land and do not expect to decide until all the evidence is available. I will follow the confirmation proceedings closely and analyze them carefully. I want to know more about his views on issues like abolition of the poll tax.

Hector, it was great to hear from you. Let's keep in touch on this and other issues of mutual concern.
