As Chairman of the Subcommittee on Economic Growth and Stabilization, I am pleased to learn that you will be able to testify before us on Friday, March 17, 1978. The hearing at which you will appear will begin at 10:30 a.m. in Room 5110 of the Dirksen Senate Office Building. These hearings are entitled Structural Unemployment and Urban Policy. A press release announcing the other witnesses will follow shortly.

The hearings will focus on the problems of structural unemployment experienced by minorities, particularly southern minorities. I am interested in ascertaining your opinion on how urban policy can address these problems.
