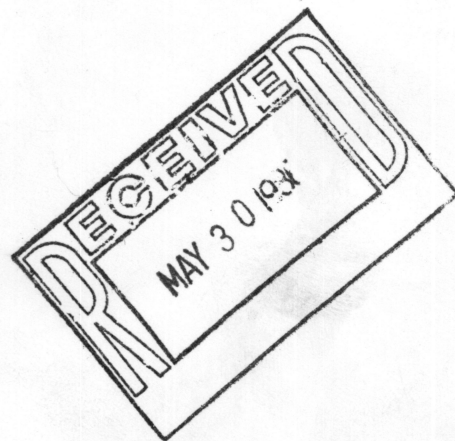

Three Rivers Livid Over TM Article

An irate Three Rivers citizenry is still seething over a quib that appeared in the June issue of *Texas Monthly* magazine, released last week. The article was in the Food section of the magazine, written by Barbara Rodriguez.

Rodriguez has written a book *Interstate Gourmet: Texas and Southwest* which was co-authored by Tom Miller. The book is to be released in June.

Rodriguez undertook the arduous task of traveling 3223 miles down the state's Interstate highway system and sampled meals all along the way, with apparent emphasis on small town eateries.

Goal of the trip was to find where to eat when you're on the road.

Three Rivers' ire is raised in the second paragraph of the article which explains what the book is about. It reads: "A word about the coyote strip that is I-37. I don't care if you haven't eaten in forty days, never, ever, stop for a bite in Three Rivers."

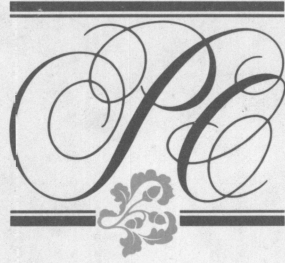

Proposed Street, Drainage Project To Be Discussed

City of George West will hold a public hearing at 7:00 p.m. on Thursday, June 5, 1986 at the Frier Hut restaurant to discuss the City's application for funding proposed street and drainage improvements under the Texas Community Development Program. The proposed project improvements are planned in an area bounded by Highway 59 on the north, Highway 281 on the west, San Antonio Street on the east, and Catholic Cemetery Road on the south.

This application has been developed based on public input received at public hearings, the most recent hearings was held on May 27, 1986. The purpose of the June 5 meeting is to inform citizens of proposed activities, costs, anticipated impacts of the project on citizens and local service levels.

The Mayor and City Council encourage public participation in this meeting.
