DEAR DAVID:

I AM FORWARDING YOU THIS VERY IMPORTANT CASE. PERHAPS IN MY OPINION AS A CIVIL RIGHTS LEADER ONE OF THE MOST IMPORTANT CASES THAT EVER HAPPEND.

IT IS ALSO IMPORTANT BECAUSE TWO OF THE AMERICAN GI FORUM ATTORNEY'S STOOD UP TO THE DEPT OF "THE ATTORNEY' GENERAL" AND THE CIVILIAN ESPIONAGE AND WON. THOSE TWO ATTORNEY'S ARE

1. ATTY. J.A. TONY CANALES MY NEWPHEW. DR. CLOTILDE GARCIA'S SON  
2. ATTRY G. RUDOLPH GARZA HIS PARTBER AND AMERICAN GI FORUM LEGAL CUNSELOR. (ALL SIX WERE KNOWN AS THE "LAREDO SIX". ALL WERE FROM SOUTH TEXAS.

I MIGHT SUGGEST DAVID AND I HAVE NEVER DONE THIS BEFORE THAT YOUR HEADLINES ON THIS STORY SHOULD BE:

" AMERICAN G I FORUM ATTORNEYS WIN CASE AGAINST THE ATTORNEY GENERAL OF THE U.S." IN REFERENCE TO GRAND JURY PROCEEDINGS. ".  
DAVID: THIS CASE IS A HISTORICAL FIRST, IT SHOULD BE AN IBSPARATION AND ENCOURGEMENT TO OUR YOUNG ATTORNEY'S TO MOVE INTO THE CIVIL RIGHTS FIELD.

THE PRESSURES WERE TERRIFIC. ORIGINALLY THE SIX ATTORNEY'S "THE LAREDO SIX". WERE FOUND GUILTY BY THE U.S. SOUTH DISTRICT IN LAREDO, TEXAS. THEY WERE INCARCERATED AND LET OUT ON BOND. THE PRESSURE WAS BORRIBLE. THEN THE FIFTH CIRCUIT COURT INTHE FIRST WEEK OF AUGUST REVERSED JUDGE CONNOLLY AND SET THEM FREE.

THIS CASE WILL GO DOWN IN HISTORY AS A GREAT VICTORY FOR THE PEOPLE VS. "AN OPPRESSIVE AND ABUSIVE GOVERNMENT". THE WHOLE ISSUE CAME OUT BECAUSE THESE SIX ATTORNEY'S REFUSED TO GIVE THE GRAND JURY (FEDERAL) IN LAREDO THE NAMES OF THE PERSON'S WHO HAD PAID THE "BONDS" FOR SOME PEOPLE WHO HAD BEEN CHARGED WITH NARCOTIC'S VIOLATIONS. AS YOU CAN SEE IT WAS A GREAT VICTORY. I KNOW THAT IT IS LONG BUT BE SURE AND GET SOMETHING IN PRINT. I CONSIDER THIS CASE IMPORTANT TO OUR AMERICAN GI FORUM.

SO GO TO IT DAVID. DO IT AS EARLY AS POSSIBLE.
