

- I. Consults with physicians and nursing staff concerning the total treatment program of each patient, making recommendations to physician concerning need for changing treatment program after reviewing patient's progress.
- J. Evaluation and initiating treatment of new patient referrals including establishing treatment care plans and responsible for periodic reassessment of patients and discharge planning, and keeping accurate, brief, and current records on all patients treated.
- K. Prepares daily patient schedule and assignments for Physical Therapy personnel.
- L. Responsible for fulfilling JCAH Standards including establishing criteria for personnel evaluations, in-service guidelines, orientation procedures for the Physical Therapy Department.
