The following list indicates the kinds of information sought from public hearings on legislative redistricting:

1. Changes in the population base of an area or district, including its ethnic, political, or socioeconomic composition;
2. Public satisfaction/dissatisfaction with present district boundaries; suggestions for district changes;
3. Locations of populations, such as neighborhoods containing concentrations of a particular ethnic group, that are politically cohesive or that have other common interest and should not be split by district boundaries;
4. History of minority participation in the political process in a particular area or district, including minority voter registration, minority voter turnout, and minority candidacy for office;
5. Existence or extent of bloc voting, coalitional voting, and crossover voting by racial or language groups in a particular area or district; political cohesiveness of identifiable racial or language groups in a particular area or district; and
6. History of discrimination in the area, particularly discrimination on account of race or language.

The committee is seeking information of any kind on these matters. Testimony need not include statistics or statistical analysis, and witnesses are not required to be experts. The committee welcomes anecdotal and narrative information, information about specific elections or candidates, and opinions or impressions on these matters. Such information will be helpful in pointing to areas and issues that warrant particular attention during the drawing and analysis of district plans.

1980 CENSUS POPULATION, 1990 PROJECTED POPULATION, AND PERCENT POPULATION CHANGE 1980 TO 1990 FOR FORT WORTH/DALLAS AND SURROUNDING AREAS

The figures below are taken from Projected Population Changes in Texas Districts, published by the Texas Legislative Council. The numbers should not be confused with actual population counts; they will not be used to redistrict. They are provided as indicators of the general direction and degree of population change between 1980 and 1990.

The population of the state is projected to have increased by about 20 percent in the last decade. Legislative and education districts that are projected to have grown by significantly less than 20 percent probably will be required to expand in the redistricting process. Because Texas may gain three new seats in Congress, congressional districts that are projected to have increased by less than 8 percent are the ones that probably will require more territory. Change in any one district, however, creates a ripple effect, and it is unlikely that any district boundaries are safe from change.

One of the purposes of the committees' outreach hearings is to take testimony regarding possible changes in district boundaries. The hearings will not be the only opportunity for such testimony; the committees welcome recommendations now, as preparation for redistricting continues, and after the census is published in April 1991.
