Regional Headquarters Organization

The United States Postal Service is divided into five regions-Southern, Central, Western, Eastern and Northeast. Southern Region Headquarters is located in Memphis, Tennessee 38166.

The Southern Region encompasses the eleven southern states of Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, Oklahoma, South Carolina, Tennessee and Texas.

The region is headed by Regional Postmaster General James J. Symbol who reports to the Senior Assistant Postmaster General, Operations, at Postal Service Headquarters in Washington, DC.

The Regional Postmaster General's headquarters includes five departments - Mail Processing, Customer Services, Finance, Employee and Labor Relations, and Real Estate and Buildings - and two special staff offices - Regional Counsel and Public and Employee Communications Division.

Each department is headed by a Regional Director who reports to the Regional Postmaster General and is responsible for providing direction of postal operations within the functional area of the department.

The Regional Counsel and General Manager, Public and Employee Communications Division, also report directly to the Regional Postmaster General.

The Regional Postmaster General is responsible for postal operations of all postal installations - over 7,200 post offices and 124,000 employees - within the region utilizing an annual budget of approximately \$2.8 billion.

Field Organization

The field organization of the Southern Region consists of eight geographic districts and 65 management sectional center areas for the coordination and direction of postal operations in over 7,200 post offices throughout the region.

DISTRICTS

Each district is headed by a manager who reports directly to the Regional Postmaster General. Each District Manager has a staff of four directors - Mail Processing, Customer Services, Finance, and Employee and Labor Relations - who are responsible to the District Manager for all postal operations within the district.

The eight districts are headquartered at the following locations:

MANAGEMENT SECTIONAL CENTERS

There are five to twelve Management Sectional Centers within each district headed by a manager/postmaster who reports directly to the District Manager. Most Sectional Center Manager/Postmasters have a staff of four directors - Mail Processing, Customer Services, Finance, and Employee and Labor Relations - who are responsible to the Sectional Center Manager for all postal operations within the sectional center. In some small management sectional centers, the functional areas of Finance and Employee and Labor Relations have been consolidated under a Director, Support. They have a staff of three directors. The postmasters of all post offices within the sectional center area report directly to the Sectional Center Manager/Postmaster.

Field Organization Cont'd.

BULK MAIL CENTERS

There are five Bulk Mail Centers in the Southern Region processing fourth class parcel post and other fourth class matter, sacks or pallets of third class advertising mail or circulars, and sacks or pallets of non-priority second class mail. Each Bulk Mail Center is headed by a General Manager who reports directly to the District Manager in whose district the Bulk Mail Center is located.
