Dear Dr. Garcia:

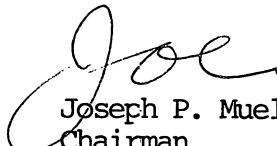
As we begin a new year I'd like to give you an annual progress report on the results of our ongoing Campaign for Progress for Memorial Medical Center.
