Reagan Will Honor Sadat,

President Reagan will award the presidential Medal of Freedom next month to 14 celebrities, including James Cagney, author Louis L'Amour

and Eunice Kennedy Shriver.
Also to be honored are Sen. Howard Baker, the Rev. Norman Vincent Peale and Tennessee Ernie Ford

Posthumous awards will be made to baseball's Jackie Robinson, Egyptian President Anwar Sadat and Whittaker Chambers, whose accusations helped lead to the conviction of Alger Hiss.

The medals, the nation's highest civilian honor, will be presented at the White House March 26.

They are awarded at the president's discretion under terms of an executive order signed by President Kennedy in 1963 to honor people "who have made an especially meritorious contribution to the security or national interest of the United States, to world peace or to cultural or other significant public or private endeavors.'

About 200 have been given.

Shriver, sister of the late president, is being honored for her work with the mentally retarded.

Also being honored are Gen. Andrew Goodpaster, former commander in chief of NATO; Dr. Denton Cooley, the pioneer in heart transplant surgery; Leo Cherne, an economist who has served as a government adviser on intelligence matters; Dr. Hector Garcia, for his contribution in the field of humanitarianism; and Lincoln Kirstein, for his contribution in the field of dance and the arts.

A top medal for Chambers, Hiss witness

WASHINGTON (AP) President Reagan will present the Medal of Freedom, the nation's highest civilian award, in the name of Whittaker Chambers, whose testimony against Alger Hiss sent him to jail for perjury.

A White House announcement named Chambers among 13 men and one woman designated to receive the award at a White House luncheon March

26.

Chambers, who died in 1961 at the age of 60, was the celebrated witness before the House Un-American Activities Committee who testified that Hiss, a State Department aide, and others in government passed him official secrets while he worked as a Soviet spy during

Hiss denied the charges, was twice tried for perjury and was convicted after binding clime. m still being fought by some of its partisans.

Others named to re-ceive the award, which is presented at the president's discretion in recognition of meritorious service, are Sen. Howard H. Baker Jr., R-Tenn.; actor James Cagney; economist Leo Cherne; heart surgeon Denton Cooley; singer Tennessee Ernie Ford; Dr. Hector Garcia; retired Army Gen. Andrew Goodpaster; ballet promoter Lincoln Kirstein; author Louis L'Amour; the Rev. Norman Vincent Peale; the late Jackie Robinson; the late Egyptian President Anwar Sadat; and Eunice Kennedy Shri-




