Dear Dr. Colmen:

As you can see from the enclosed clippings, there is great discontent in the Mexican American community with the administration of the welfare program in the State of Texas.

The community has been thoroughly alienated by the recent statements of the Welfare Commissioner that if there is any malnutrition among Mexican American children, it stems from the ignorance of their mothers -- not poverty. As a result, Ambassador Garcia has called for Commissioner Hackney's dismissal.

The Commissioner's incredible statement is, unfortunately, not an isolated phenomenon. We would like the appropriate people at the Department to look into the staffing pattern of the State Department of Public Welfare because our information suggests that there must be discrimination in the hiring and promotional practices of the Department.

We have enclosed a list of the ranking 114 officials of the State Department; on this list we find only one name which may be Spanish, that of Ray Barron, a staff services assistant.

Given the million or more Texans of Mexican descent, it can be no coincidence that Mexican Americans are so under-represented on this list.

Please let us know what can be done about this situation.
