I HAVE RECEIVED YOUR LETTER OF JUNE 13, 1962. I WANT TO THANK YOU FOR YOUR INFORMATION CONCERNING THE VETERAN'S ADMINISTRATION PROGRAM CLOSING DOWN THE CENTERS. HOWEVER, I STILL DISAGREE WITH YOU. I THINK A SERIOUS MISTAKE WAS MADE IN CLOSING DOWN THE CORPUS CHRISTI VETERANS ADMINISTRATION'S OFFICE. IT SEEMS TO ME THAT AS LARGE AN AREA AS THIS AND AS MANY VETERANS AS WE HAVE SOUTH OF SAN ANTONIO THAT YOU WOULD NOW HAVE A FULL TIME OFFICE AVAILABLE FOR THE VETERANS, THE WIDOWS AND THE FAMILIES OF THE VETERANS

YOU MENTIONED SOMEWHERE THAT A LOT OF COMMUNICATIONS CAN BE DONE BY MAIL. THIS, I BISAGREE WITH YOU THE MAJORITY OF THE VETERAN'S FAMILIES IN THIS AREA ARE NOT ABLE TO READ AND WRITE AND ALTHOUGH SOME OF THE VETERANS MAY BE ABLE TO DO THEY STILL HAVE DIFFICULTY. I SHOULD KNOW SO BECAUSE MY OFFICE HANDLES AN AVERAGE OF ABOUT 6 TO 8 PROBLEMS AFFECTING VETERANS THAT COULD BE HANDLED THROUGH A VETERAN'S OFFICE HERE IN CORPUS CHRISTI, TEXAS. I AM SUBMITTING THIS LETTER WITH ALL RESPECT TO YOU AND I AM ASKING YOU FOR RE-CONSIDERATION ON ESTABLISHING OR RE-OPENING THE CORPUS CHRISTI VETERAN'S OFFICE ON A FULL TIME BASIS. WE NEED IT BADLY. THE SERVICES RENDERED ARE NOT SUFFICIENT. THEREFORE, | BEG TO DIS-AGREE WITH YOU AND HOPE THAT ALL CONSIDERATION IS GIVEN TO THIS PROBLEM BECAUSE THIS OFFICE HERE IN CORPUS CHRISTI COULD ALSO I WILL BE GLAD TO GIVE THIS NEW SERVE ALL THE SOUTH TEXAS AREA. OFFICE RADIO TIME AND ANNOUNCEMENT AT NO EXPENSE TO THE GOVERNMENT IN ORDER THAT WE COULD KEEP OUR VETERANS INFORMED BETTER AS TO THEIR RIGHTS AND PRIVILEDGES AND ALSO AS TO THIS NEW OFFICE.
