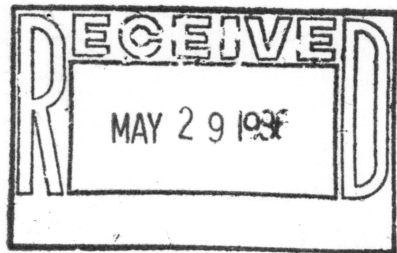

TO: A-FAST BAIL BONDS and JUAN JOSE COLMENERO Defendant Bail Bond No. _____

We, A-FAST BAIL BONDS and JUAN JOSE COLMENERO Defendant, do hereby agree that for A-FAST BAIL BONDS to continue to act as bail for said Defendant, we both will comply with the following Terms and Conditions, and Rules and Regulations:

TERMS AND CONDITIONS

- (a) Defendant shall not depart the jurisdiction of Court without written consent of the Court and A-FAST BAIL BONDS, or its Agent.
- (b) Defendant shall not move from one address to another without notifying A-FAST BAIL BONDS or its Agent in writing prior to said move.
- (c) Defendant shall not commit any act which constitutes reasonable evidence of Defendant's intention to cause a forfeiture of said bond.
- (d) Defendant shall notify A-FAST BAIL BONDS or its Agent of any arrest other than a minor traffic violation.
- (e) Defendant shall not make any material false statement in the application in which said Defendant applies to A-FAST BAIL BONDS to act as his bail in the amount of \$2500.00 in the any Dist. Court of Hidalgo Co. TX, where said Defendant is charged with the offense of agg. sexual assault

RULES AND REGULATIONS

- (1) The Defendant shall call the office of A-FAST BAIL BONDS on the Monday of each week. The Defendant shall give his full name. The Defendant must be sure the person answering marks down the fact that he has checked in. The phone is answered 24 hours a day so there is no excuse for not reporting. Failure to report may constitute a breach of the conditions set forth in Section (c) of Terms and Conditions. 381-9841
- (2) Any time the Defendant changes his address at home, work, or his phone number is changed or disconnected, the Defendant shall notify A-FAST BAIL BONDS at once.
- (3) The Defendant shall not leave Hidalgo County, Texas at any time without prior permission as stated above in Section (a) of Terms and Conditions.
- (4) The Defendant will be notified by mail and phoned (when phone is available) of his date to appear in Court. The Defendant must sign and return that letter at once, to A-FAST BAIL BONDS, P.O. Box 291, Edinburg, Texas 78539.
- (5) After his appearance in Court, the Defendant shall call A-FAST BAIL BONDS and let the person answering know the outcome of the case. Also notify A-FAST BAIL BONDS of any future Court dates set by the Court.
- (6) The Defendant's failure to follow these rules and regulations, and terms and conditions will result in A-FAST BAIL BONDS asking for a warrant to be issued for Defendant's arrest so that A-FAST BAIL BONDS may be released from said bond, as provided by law.
- (7) The bond(s) written by A-FAST BAIL BONDS for Defendant are not an appeal bond(s) and can not be used by Defendant or the Court as an appeal bond(s) unless the Defendant and A-FAST BAIL BONDS or its Agent agree in writing to additionally use said bond as an appeal bond.
- (8) Should the Defendant fail to appear in Court when notified, a warrant will be issued for his arrest. Should the Defendant not appear after being notified and a judgment nisi is entered against A-FAST BAIL BONDS or its Agent, A-FAST BAIL BONDS will ask that criminal charges for bond jumping be brought against the Defendant. This crime is defined in Texas Penal Code's Section 38.11(a) as:
"A person lawfully released from custody, with or without bail, on condition that he subsequently appear commits an offense if he intentionally or knowingly fails to appear in accordance with the terms of his release."

I, the Defendant, hereby acknowledge having read or being explained by _____ the above terms and conditions, and rules and regulations and I agree to abide and follow them as long as A-FAST BAIL BONDS shall remain as surety on my bond(s). Should I fail to follow these instructions, I understand that A-FAST BAIL BONDS cannot and will not remain on said bond(s), and a warrant may be issued as provided by law and I will be reprimanded to and locked up in the county jail from which I was bailed out of by A-FAST BAIL BONDS.
