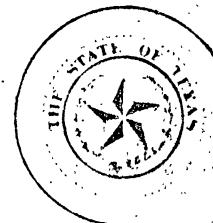

THIRD QUARTERLY MEETING - MCALLEN

FINAL ARRANGEMENTS HAVE BEEN MADE FOR THE THIRD QUARTERLY MEETING IN MCALLEN, ON AUGUST 10, 1974, AT THE SHERATON-FAIRWAY MOTOR HOTEL. THE MEETING, WHICH WILL BEGIN PROMPTLY AT 9:00 A.M., PROMISES TO BE ATTENDED BY ALL COMMISSIONERS AND THE AGENDA INCLUDES A HIGHLY INTERESTING AND VARIED NUMBER OF ITEMS. THERE WILL BE A BRIEF ADDRESS BY DR. HECTOR P. GARCIA, CORPUS CHRISTI, FOUNDER OF THE G.I. FORUM AND FORMER MEMBER OF THE U.S. COMMISSION ON CIVIL RIGHTS; AND A REPORT BY A REPRESENTATIVE FROM THE IMMIGRATION & NATURALIZATION SERVICE DETENTION/DEPORTATION CENTER AT LOS FRESNOS, TEXAS.

IGNC BOARD OF DIRECTORS MEETING

EXECUTIVE DIRECTOR ATTENDED THE BOARD OF DIRECTORS MEETING OF THE INTERNATIONAL GOOD NEIGHBOR COUNCIL IN MONTERREY, MEXICO, ON JULY 20, 1974. IT WAS AN IMPORTANT AND A VERY SIGNIFICANT MEETING IN THAT REPORTS MADE DURING THE SESSIONS REVEALED THAT THE FINANCIAL CONDITION OF THE ORGANIZATION IS AT ITS BEST DURING ITS 20 YEAR HISTORY. MANUEL JARA, OF THE FT. WORTH CHAPTER, REPORTS THAT THE ASSEMBLY TO BE HELD IN FT. WORTH ON OCTOBER 17-20, 1974, PROMISES TO DRAW A RECORD NUMBER OF DELEGATES FROM TEXAS, NEW MEXICO AND NORTHERN MEXICO.
