Dear Mr. Arredondo:

Reference is made to our telephone conversation of this date concerning the garbage feeding operation of Mr. Julio R. Sandoval, Nueces County.

Dr. Byron White, Area Veterinarian in charge of Garbage Inspection responsibility in Nueces County reported by telephone this date to Dr. Sibley and I that he had contacted Mr. Sandoval, in person, Monday, February 25, 1974. At the present time, according to Dr. White, Mr. Sandoval's operation is in compliance with all of the Commission's garbage feeding laws and regulations. The most recent premise and garbage inspection was made by Inspector Johnnie Perez, February 22, 1974, and indicated that Mr. Sandoval's operation was completely satisfactory in regard to the garbage law and regulations.

Dr. White indicated that Mr. Sandoval expressed a desire to revert back to wood as fuel for his heat to cook the garbage but Dr. White explained that this exception could not be made and he would have to continue to use fuel oil or natural gas as he is presently doing. To sum it up, Dr. White was very pleased with Mr. Sandoval's garbage feeding operation.
