DEAR SENATOR TOWER:

PERSONS WHO ARE NOT EXPERIENCED OR INVOLVED IN THE SCHOOL SEGREGATION AND DISCRIMINATION OF MEXICAN AMERICAN CHILDREN IN THE SCUTHWEST AND SPECIALLY IN TEXAS OFTEN MAKE STATEMENTS AS:

1. I APPROVE OF SCHOOLS FOR ALL CHILDREN CONCERNED. SEPERATE AND EQUAL SCHOOLS ARE FINE.

2. THE NEIGHBORHOOD PLANS OF SCHOOL ZONING IS A VERY FUNDAMENTAL AMERICAN DEMOCRATIC PRINCIPLE. FREE CHOICE IS THE ANSWER.

*** I AM FOR INTEGRATION OF ALL CHILDREN PROVIDED 3. THERE IS NO BUSSING OR BREAKING UP OF THE NEIGHTBORHOOD CONCEPT.

THOSE OF US WHO HAVE BEEN FIGHTING SCHOOL DISCRIMINATION AND SEGREGATION OF MEXICAN AMERICAN CHILDREN FOR OVER 25 NEARS ARE APPALED AND SURPISEDAT THE NAIVITY AND IGNORANCE OF PUBLIC OFFICIALS MAKING SUCH STATEMENTS.

SUFFICE IT TO SAY THAT THE WHOLE PATTERN OF SECHOOL SEGREGATION & DISCRIMINATION OF THE MEXICAN AMERICAN CHILD HAS ALLWAYS BEEN ILLEGAL AND UNCONSTITUTIONAL EVEN BY THE TEXAS CONSTITUTION" THAT MERELY STATED THERE WILL BE SEBARATE SCHOOLS FOF THE BLACKS".

THE NEEGHBORHOOD CONCEPT, FREE CHOICE, SEPARATE SCHOOLS, GERRYMANDERING OF SCHOOL DISTRICTS HAVE ALLWAYS BEEN USED AND ARE STILL BEING USED IN TEXAS AND IN THE SOUTHWEST U.S. TO PERPETUATE THE SEGREAGATION OF MEXICAN AMERICAN CHILDREN. THIS HAS NOT ONLY BEEN ACCEPTED BY THE TEXAS EDUCATION AGENCY BUT HAS ALSO BEEN STATED BY EVERY FEDERAL COURT, HEARING SUCH CASES. Cent I AM ENCLOSING A REPORT OF THE TEXAS DEPARTMENT OF HEALTH AND THEIR INVESTIGATION OF SUCH THREE SCHOOLS IN CORPUS CHRISTI TEXAS THE SURVEY HAVING BEEN DONE ON JUNE 1971. PLEASE READ THE REPORTIN DETAIL.

THESE THREE SCHOOLS, THE ZUSTIN ELEMENTARY THE DE ZAVALA & THE SOUTHAGETE ARE IN A SCHOKNING STATE. THEY ARE ALL THORE BIRE HAZARDS AND THEALTH HAZARDS. THESE ARE TYPICAL SCHOOLS THAT ARE A PRODUCT AND RESULT OF THE ABOVE ENNUMERATED POLICIES. IT IS A GREAT SHAME THAT ALL OF US SPECIALLY PUBLIC OFFICIALS HAVE CONDONED DOUCH SCHOOLS FOR THE MEXICAN CHILDREN.

NOTE THET IN ALL THREE SCHOOLS SOME OF THEM OVER 30 YEARS OLD THERE IS NOT A "SINGLE HYDRANT OF HOT RUNNING WATER." THIS IS NOT THE EXCEPTION BUT RATHER IT IS THE TYPICAL EXAMPLE OF THE DAMABE THAT HAS BEEN DONE TO THE EDUCATION, LIFE, AND STATE OF MIND OF THE MEXICAN AMERICAN CHILD BY THE EDUCATIONAL SSTEM

OF TEXAS AND THE SOUWHWEST.

THE AMERICAN G.I. FORUM, LU,LCAS, GUSTAVO GARCIA, DR. GEORGE I SAN CHEZ AND MYSELF HAVE BEEN EXPOSING THESE SHAMEFUL CONDITIONS FOR OVER 25 YEARS. OUR VOICES HAVE BEEN UNHEARD BY THE STATE OFFICIALS. OUR PETTITIONS HAVE BEEN WRITTEN OFF AS IRREVE VANT AND UNNECESARY. OUR ECOUMENTATION HAS BEEN TAGGED AS COMING FROM "TROUBLE MAKERS" OR WEGSE.

AMERICAN CHILD IS ONLY SLIGHTLYBETTER THAN 25 YEARS AGO. WE ARE STILL FICTIMS OF THE "DEPACT)) " DE FACTO & DE JURE SEGREGATION".

PLEASE READ THE REPORT AND LET MY KNOW WHAT ANSWER YOU HAVE FOR SUCH CONDITIONS. WHO IS RESPONSIBLE? WHAT HAVE NOT THE HEALTH AUTHETTIES AND THE FIRE DEPARTMENTS TOLERATED SUCH HORRIBLE CONDITONS. WHY HAVE NOT THE STATE OFFICERS AND THE TEXAS ELECTED OFFICERS TO THE U.S. CONGRESS PASSY PASS LEGISLATION TO STOP THIS EXPLOITATION.

WHAT IS IT THAT YOU CAN DO TO HELP SUCH STATEWIDE AND WOUTHWEST WIDE SCHOOL SYSTEMS. I AM NOT AN ELECTIVE OFFICIAL BUT I FEEL THAT I MUST KEEP ON SEEKING A SOLUTION FOR** TO GIVE THE MEXICAN AMERICAN CHILD BETTER EDUCATION. YOU MUST JOIN ME IN THES RESPONSIBLITY.

IT IS EASY WHEN THE OTHER SIDE, AND THE CONCERNED PARENTS ASK YOU TO OPPOSE "BUSSING" OR "FORCED BUSSING" TO LISTEN TO THEM. BUT BUSSING IS NOT THE ISSUE. THE ISSUE IS THE POOR SCHOOL SYSTEM IN TEXAS AND THE S.W. THAT HAVE PRODUCED SUCH A POOR LEVEL OF DUCATION AND ATTAINMENT OF THE MEXICAN AMERICAN CHILD.

BEFORE ANYMORE PUBLIC STATEMENTS ARE MADE BY PUBLIC OFFICIALS CONCERNING "BUSSING" I AM ASKING YOU TO SOLVE THE MAIN PROBLEM OF SUCH SCHOOLS, AS AUSTIN, ZAVALA & SOUTHAGE WHICH ARE TYPICAL IN TEXAS.

ONLY

DO NOT BE COMPERTERY CONCERNED WITH THE AFFLUENT AND ARTTCCALTE CONCERNED PARENTS BUT BE CONCERNED WITH THE HORRIBLE INDICTMNT OF THE SYSTEM OF WHICH YOU AND I HAVE BEEN EITHER SILENT PARENTS OR WILLING PARENERS.

PERHAPS A CONGRESSIONAL INVESTIGATION IS IN ORDER OF THE STATEWIDE EDUCATIMAL SYSTEM. FOR DOCUMENTATION YOU NOT ONLY HAVE THE ENCLOSED REPORT BUT ALSO YOU CAN FIND THIS INFORMATION IN; MANY U.S. COMMISSION ON CIVIL RIGHTS BOOKS AND SPECIFICALLY :
