Dear Dr. Garcia:

We, the Texas Department of Human Resources Income Assistance Services employees (Food Stamps and Welfare), are deeply concerned at current delays in providing desperately needed assistance to our clients. These delays are caused by an ever increasing workload and inadequate staffing in the local office. These problems also exist throughout the State of Texas.

Since we have not received any relief from administrators and cannot expect any in the foreseeable future due to the current freeze on hiring, we are planning a demonstration during our lunch hour on February 14, 1985 to express our frustrations with the current situation. The demonstration will be at 5277 Old Brownsville Road between 12:00 Noon and 1:00 p.m.

Since most of us are Texas State Employees Union, CWA/AFL-CIO members, we are actively seeking the aid of fellow labor union members, as well as community agencies and interested parties in expressing our concern about the current conditions. We will appreciate any assistance that you can offer from a statement of support to joining us in our demonstration.
