## Nueces County Medical Society Community Blood Bank Board of Trustees Meeting December 12, 1973

The regular meeting of the Board of Trustees of the Nueces County Medical Society Community Blood Bank was held at 6:30 p.m., December 12, 1973 at the Corpus Christi Country Club.

Members present: Drs. John W. Chriss, Sidney M. Conolly, H. Ross Garza, Everett L. Holt, Herbert E. Madalin, Vernon Medlin, Henry Saenz, and Richard R. Woods.

Also present: W. W. Henderson, Executive Director

The meeting was called to order by the President, Dr. Henry Saenz.

The minutes of the last meeting held November 20, 1973 were read. There were no corrections and the minutes were directed to stand as read.

The Executive Director next made a short report on progress of the Blood Bank during the month of November. Mr. Henderson reported that the Blood Bank had drawn 927 units of blood and that 890 whole blood and packed red cells had been reported transfused. In addition there were 68 cryoprecipitates (Factor VIII), 18 platelet concentrates, 14 Fresh Frozen Plasma and 2 washed Red Blood Cells infused to patients. Of the 927 units drawn there were 356 drawn on the mobile unit and represents 38.4% of the blood banks blood income. We shipped 42 units of blood and four Fresh Frozen Plasma to other Blood Banks out of the area and received 23 units through the Clearinghouse. The Parkdale note of \$5,328.07 was paid off and our Capital Improvement Fund remained intact. The financial statement shows a net gain of \$3,644.21.

The next item of business was consideration of the Financial Statement prepared by the firm of Peat, Marwick and Mitchell. The statement was reviewed and approved.

Old business was next in order. It was reported by Mr. Henderson that he had not yet had time to visit with the hospital administrators concerning the recovery of Plasma but that he would do so at the earliest opportunity.

It was announced that Drs. H.Ross Garza, Francis M. Parks and Henry Saenz, had accepted nominations for re-election to the Board of Trustees.

New Business: Mr. Henderson reported that he had been approached by the representative of the ARADMAC All Star Bowling League to sponsor a bowling team. The cost would be \$80.00 and includes the name of the Blood Bank on all team member shirts, entry fee and portion on trophies. It was pointed out that ARADMAC has the largest Donor Club with the Blood Bank and have provided donor help in several blood emergencies. The league bowls at Gulf Bowl and is a 7:00 p.m. start. The league goes thru May 1974.

It was moved by Dr. John W. Chriss and seconded by Dr. Sidney M. Conolly that the Blood Bank be authorized to sponsor the bowling team and that the money be allocated from the Donor Education account. This motion was put to a vote and carried.

Further under new business, Dr. Chriss discussed the pending National Blood Program and suggested that the Blood Bank should leave the door open to possible expansion in order to qualify as a Regional Blood Center under the pending law.

There being no further business a motion was properly made and seconded that the meeting be adjourned. The meeting was adjourned.
