#### Christine Shupala Named New Library Director

The Bell Library is pleased to announce that Christine Shupala accepted the position of Library Director on July 1, 2003.

Chris has held a variety of positions in the Bell Library in the Public Services and Technical Services divisions. She was originally hired as the Reference/Government Documents Librarian in 1995 and then became the Catalog/Technical Services Librarian in 1997. She was then promoted to Interim Associate Director for Systems and Technical Services in 1998 and became the permanent Associate Director in 1999. She served on the Library Management Team from 1998 to 1999 and again from 2002 to 2003.



Chris has served on a number of committees at A&M – Corpus Christi in the past eight years, including committees

that focused on University budgets, planning, information technology, distributed learning, Web authoring, institutional effectiveness, and accreditation from the Southern Association of Colleges and Schools. She also served on Faculty Senate and was an instructor in the Freshman Seminar Program in 1996.

#### Library Increases Operating Hours

As part of its ongoing efforts to expand and improve services, the Bell Library will be increasing its operating hours, beginning the first day of the Fall 2003 Semester. Effective August 27, 2003, the Library will be open these hours:

Sunday: Noon - 1:30 a.m.

Monday − Thursday: 7:30 a.m. − 1:30 a.m.

Friday: 7:30 a.m. -8 p.m. Saturday: 10 a.m. -8 p.m.

The library increased its operating hours by 14.5 hours after it conducted an expanded hours project last spring. The staff kept statistics on transactions at the service desk and labs, as well as the number of people who were in the building every half hour after midnight. Based on an analysis of the data, the Library Management Team recommended increasing the number of hours of operation, which was approved by the President's Cabinet.

### Library Prepares for Tropical Storm Claudette

While the Library generally welcomes all users, a potential visitor caused an unusually large amount of preparation for the staff: Tropical Storm Claudette, which formed in the lower Caribbean in early July.

On July 11, while Claudette was trying to decide where to land on the Texas coast, the Library staff began implementing its already-established hurricane defense plan on orders from the University Administration. That day, the staff began "bagging" PCs in their work areas before they left for the weekend. They also began pulling rolls of already-cut plastic sheets and taking them to the corresponding shelf ranges on the second floor.

On July 14, a total of 20 people, including Library staff, student workers, custodians and even one or two library patrons, covered the collections on the second floor in only an hour-and-a-half. All of the areas of Special Collections and Archives were covered that day, too.

On the morning of July 15, the campus closed down, and the Library staff taped the plastic sheeting to the ends of all the shelf ranges between 7:30 and 9 a.m. The Systems staff ran backups, and other staff members finished "bagging" the PCs in the Public Services areas, including the computer labs. Several staff members also moved the materials from the bottom shelves of the Reference collection to the top shelves in case of flooding on the first floor. When the campus opened on July 16, the staff pulled down all of the plastic and folded and stored the sheets.

Every May, the Library reviews and revises its storm defense plan, which outlines in detail the types of alerts and the procedures for each alert. Teams are formed to carry out specific tasks. Also, in the middle of May, the entire staff meets to review the plan and carry out the procedures and drills before the begining of Hurricane Season.

#### Spotlight on: Web of Science

**Web of Science** is a database that provides online access to bibliographic information from thousands of scholarly journals in all major disciplines. Users can search for bibliographic information for articles, as well as articles and other sources that were <u>cited</u> in those articles. Researchers can also use this resource to determine if people have cited their work, as well as the frequency with which they have been cited.

This database includes three citation indices from 1993 to the present:

- j Science Citation Index
- j Social Sciences Citation Index
- i Arts & Humanities Citation Index

Users may perform basic searching, general searching or cited reference searching.

# TDNet will replace Periodicals Holdings List

Beginning this fall, library patrons will be using a new resource to check the availability of journals in all formats.

The Library has purchased TDNet, a web-based journal management tool that will replace the current Periodicals Holdings List and will help us to provide access to all of our periodical holdings (print, microform, and electronic) from a single source.

The greatest benefits of TDNet are a title-level subject searching function and a current listing of all of the titles to which the library subscribes. The subject searching function is based on Library of Congress Subject Headings and is provided via a series of drop-down lists that allow the user to create as broad or narrow a journal title search as they wish.

TDNet will include links to all of the titles to which the library has electronic access through both publishers' websites (e.g. the Nature titles) and through full-text databases (e.g. Academic Search Premier and LexisNexis). Of course, TDNet will include our print and microform holdings too, with links to Portal, the online catalog.

The Periodicals Department will work with the creators of TDNet through the summer to customize the Bell Library's new Periodicals Holdings List by TDNet.



#### Special Collections & Archives: Two Recent Books featuring Dr. Hector P. Garcia



The academic year 2002-2003 culminated with the publication of two books about Dr. Hector P. Garcia which were fundamentally based on the Dr. Hector P. Garcia Papers in Special Collections & Archives. The first of these works is Ignacio M. Garcia, Hector P. Garcia: In Relentless Pursuit of Justice (Houston: Arte Publico Press, 2002). It is the first full length biography of the



legendary Corpus Christi physician and champion of civil rights. Professor Garcia effectively argues that Dr. Hector's leadership in the post World War II period defined "a Garcia Age in Latino history in the United States." In this three hundred plus page biography, Professor Garcia demonatrates Dr. Hector's "whole-hearted commitment to social reform and willingness to pay any price and travel anywhere for his raza." A member of the history faculty of Brigham Young University, Dr. Garcia authored the award-winning *Viva Kennedy: Mexican Americans in Search of Camelot* in 2000, also largely based on the Garcia Papers.

Patrick J. Carroll's Felix Longoria's Wake: Bereavement, Racism, and the Rise of Meixcan American Activism (University of Texas Press: Austin, 2003) is the second of these volumes. Longtime history professor at A&M-Corpus Christi, Dr. Carroll has produced a masterful work. His study represents the culmination of a commitment to Dr. Hector to



do a book on the Longoria Incident, a pivotal episode in Dr. Hector's life as well as in Mexican American history. Though he details the role played by Dr. Hector and others, Dr. Carroll also explores the incident's national and internation ramifications. The author interviewed some seventy five people and combed many sources to finish the project; but he began it with Dr. Hector and Dr. Hector's papers as a foundation.
