THERE WERE TWO BROADSASTS THE FOLLOWING DAYS ONE IN THE MORNING MORE INTENSIVE THAN THE OTHER. BY NAME WAS NOT SPECILEC OUT HOW VER EVERYONG KNEW I HAD A MEETING THERE AND THE WORDS "EN CIERTO DOCTOR NO QUZO AYUDAR A UNA SENORA MUY ENFERMA.

THEREFORE YOUR LETTER SHOULD #8% OR STATE:

GIMMY OF COURSE I FEEL THAT BESIDES THE ADVANTAGE OF REQUESTING THE COPIES OR THE SCRIPT IS THAT WE CAN SAY WE WERE OR I WAS DAMAGED PROFESSION ALLY SINCE IT WAS A MEDICAL QUESTION AND THE WORDS "DOCTOR" WERE USED.
