THE AMERICAN GI FORUM DEPT OF CALIFORNIA REQUEST THAT THE AMERICAN GI FORUM OF THE STATE OF TEXAS DEMAND THAT U.S. FEDERAL MARSHALLS CONDUCT A SEPARATE INVESTIGATION IN THE INVASION OF PRIVACY AND CRUEL AND UNUSUAL PUNISHMENT INFLICTED TO THOMAS RODRIQUEZ, WIFE AND THEIR EIGHT CHILDREN ON 2/19/71 IN DALLAS TEXAS. GORSS MULTIPLE VIOLATIONS OF THE U.S. CONSTITUTION BY OFFICERS INVOLVED IN THE RAID IN QUESTION SEEM CLEAR IN THIS CASE. PLEASE REFER FOR RESEARCH TO MR. CARLOS VELA, ATTORNEY NATIONAL CIVIL RIGHTS CHAIRMAN - U.S. COURT OF APPEALS FOR 5TH CIRCUIT CASE OF ANDREW HAWKINS VS.
